KEEP YOUR WALLET FAT

Act fast if you want to pay 2015 property taxes in smaller installments. Sign up for our Installment Payment Plan by April 30. This plan gives you the flexibility to make quarterly payments while also receiving a discount of slightly under 4%. To apply, submit an online application at www.pbctax.com/installment-payment-plan.



AVOID EXPENSIVE TICKETS

Motor vehicle registrations must be renewed on or before the owner's birthday. Prevent the last-minute rush and avoid expensive traffic tickets! Mail or drop off payments at six of our eight office locations up to 90 days before the expiration date. Be sure to leave our office enough time to process and mail your registration.



BEAT THE CROWDS



Did you know you can make an appointment for driver license services online? That's just one way we're making your visit hassle-free. You can also check the live wait times at our eight office locations at www. pbctax.com. They're updated every 60 seconds! The easiest way to save time is to use our secure Online Payment Center. Visit http://bit.ly/1DT0G0h to learn which services you must complete at a service center. Remember, you cannot become REAL ID'd online. You must come to service center with the appropriate documentation.



SKIP THE SALE

Still haven't paid 2014 property taxes? We must receive payment by May 29 at 5 p.m. to avoid the annual tax certificate sale on June 1, 2015. A tax certificate is a first lien created when someone else pays your delinquent taxes. If you fail to pay delinquent taxes within 2 years, the tax certificate buyer can file a Tax Deed Application. This begins the process of the property being sold at public auction.

STILL HAVEN'T PAID 2014 PROPERTY TAXES?

Unpaid 2014 property taxes are now delinquent. Delinquent taxes are charged a minimum 3% interest plus advertising fees. Interest accrues up to 1.5% per month (18% annually). Delinquent taxes cannot be paid online. For more information, visit pbctax.com/delinquent-property-tax.

OFFICE CLOSURES: PLAN AHEAD WITH A NEW SERVICE CENTER

Beginning June 29, the Tax Collector will be the only Palm Beach County office offering motor vehicle services. The Florida Department of Highway Safety and Motor Vehicles (FDHSMV) office in Lake Worth (571 N. Military Trail) will close for good on June 26.

We are pleased to announce that we are slated to open a new, full-service office in Lake Worth (4215 S. Military Trail) in November 2015. This new service center will replace our current Lake Worth (3551 S. Military Trail) and Lantana (1299 W. Lantana Road) offices, which are both scheduled to close in fall 2015. Plan ahead and utilize our online services during these transitions.
